Dear Friends and Members,

I would like to take this opportunity to thank everyone who came out to support our last ASPE Dinner Meeting Simpson Strong Tie with CA Territory Manager, Ryan Swenson. The entire evening was truly enjoyable. ASPE appreciate the time, effort and skills of the guest speaker. The audience turnout was great & excited.

In today's construction market Levels of the estimate are not well known. Every level of the estimates represents the evolution of the design information and what format we need to

present the estimate in the early stages like Uniformat (level 1-2) and CSI Format (level 3-5) for substantial and complete information.

LEVELS OF THE ESTIMATE as a project is proposed and developed, estimate preparation and information will change based on the needs of the Owner, Client, or Designer. These changes will require estimates to be prepared at different levels of detail during the design, with varying degrees of information provided. It should also be noted that within each level of estimate preparation, not all portions of the design will be at the same level of completeness. For example, the architectural design may be at 80% or 90% complete, while the mechanical design is only at 50% complete. This is common through the design process but should be noted in the estimate narrative. The levels of estimate correspond to the typical design process and are considered standard within the industry. These levels are as follows: Order of magnitude (Level One) Schematic or Conceptual Design (Level Two) Design Development (Level Three) Construction Document (Level Four) Bid (Level Five)

Design and Redesign

The current architectural team of Gordon Carrier and team from Carrier Johnson + Culture truly re-envisioned the original project in scope, approach, and inspiration. Originally designed with Roman architectural influences spanning a range of 532,000 SF, the current design team eliminated 200,000 SF and included modern design elements, making the buildings look contemporary, clean, and welcoming to all passersby while creating a place and vision that inspired meditation on the principles Cerullo teaches.

The redesign was due to the city's environmental impact report and concerns about traffic congestion among other issues. The traffic concern has been resolved by adding a lane to Hotel Circle South across the entire project length. Cerullo must maintain a count of vehicles that enter the facility's driveway over the first 3 years.

Traffic concerns and solution

Cerullo's response to the city's concerns has been well received and with Carrier Johnson + Culture's approach, the project will be the timeless resort that welcomes visitors to immerse the culture around the grounds and leave their troubles at the door.

Construction features

Each building features deep foundations, cast-in-place concrete, and metal panel canopy and plaster. The vision center and museum features mechanically fastened stone and structural glazing while the pavilion features concrete on metal deck, curtain wall and adhered stone.

In addition to the landscaping and buildings, there is a 4-floor 418-stall parking garage which will hold the central utility plant.

Anticipated opening

The \$160 million project is set to open to the public late 2019, early 2020.

Ask a CPE: Q & A

Responses from Wrey Farrales, CPE—Senior Cost Manager, HL Construction Management

1. When did you get your CPE certification?

I had my certification on October 15, 2015.

2. What made you take the CPE certification?

I considered acquiring this certificate early on in my career. The title of CPE holds significance and recognizes me as a qualified and competent estimator. The certification process was an essential step in my career development.

This certification demonstrated my commitment to the industry and estimating profession.

3. How is it useful for you to have the CPE certification?

I have highlighted my CPE certificate as a bullet point on my resume. This reflects the highest form of professional recognition.

My resume includes my certificate and affiliations, and I have submitted my resume multiple times on RFP's and proposals, and it has been a part of my success in getting awarded contracts, based upon my resume.

4. What do you suggest to other estimators regarding getting certified?

I would highly recommend other estimators to pursue the CPE certificate, as it shows that you are a committed and highly educated and motivated person. It should build your confidence and reflects personal achievement.

Many companies and government agencies are starting to require these certificates.

5. Brief description of your certification process, estimating life and any other comments?

From my experience, the process was natural flowing as long as you know the basic principles of estimating. During my certification process – I did my review of the bylaws of the organization and all the regulations of doing an estimate. Doing the estimate itself was not too difficult as long as you understand the principle.

I have been fortunate to have worked with many well-known firms, and alongside competent architects and estimators on projects located in the Philippines, Hawaii, and Southern California. I think my certificate has been one small step to solidifying my advancement in the construction industry, and my exposure to award-winning proposals in the gaming, hospitality, education, and healthcare sectors.

Recap Article about the March 2019 ASPE Dinner Meeting: "Strengthening Structures, Empowering Engineers, and Aiding Contractors: Simpson Strong-Tie's Solutions to Industry Problems"



SPE San Diego Chapter #4 has recently been favored with several representatives from Simpson-Strong Tie attending our dinner meeting programs. With the postponement of Gafcon, Inc.'s presentation on the redevelopment of Seaport Village, we



inquired if their company would be interested in serving as our speaker for the March 19, 2019 program. Ryan Swenson, Territory Manager for Southern California, was enthusiastic about the opportunity, and our 9 members and 9 guests in attendance at The Hunter Steakhouse were not disappointed by their

appearance and message conveyed to the group.

The Programs Committee is always concerned that suppliers and vendors do not just deliver a "sales pitch" about their products when putting on a program at our dinner meetings. While Simpson Strong-Tie's three representatives brought a plethora of catalogs displaying the full range of materials available to the construction process, the discussions centered on three videos shown for our benefit and enlightenment about the services provided by their firm to the industry. These videos were both educational and entertaining in communicating the following three subject matters.

We learned about their state-of-the-art testing facility in Pleasanton, CA, located outside of the Bay Area in Northern California. Most interesting was the video about the world's largest Earthquake Seismic Testing Table located north of Kobe, Japan. That complex houses a 65-foot by 49-foot table which can support building experiments weighing over 2 million pounds. (Please refer to <u>attached Feature Story</u>.) Local construction professionals may be aware of the former UCSD shake table in Scripps Ranch to study masonry structures. Simpson Strong-Tie's organization, in concert with other industry partners, constructed a 7-story wood frame assembly using various structural connectors to test the results during a simulated catastrophic disaster. Finally, it is significant to note their firm's involvement in studying why certain buildings were undamaged by Hurricane Michael in Mexico Beach along the Florida panhandle in 2018. The graphic pictures were remarkable in comparing those homes and retail shops built with Best Practices vs. those using less structurally sound components.

We appreciate the efforts of Simpson Strong-Tie's local people in presenting a most informative program. San Diego Chapter #4 looks forward to their continuing support of our activities and becoming active members of the Society.

Full-Scale Building Tests on World's Largest Earthquake Shaking <u>Table</u>



Located just north of Kobe in Miki City, Japan, the E-Defense shake table measures approximately 65 by 49 ft. and can support building experiments weighing over two million pounds.

Tremors lasted only 20 seconds during the disastrous 1995 Kobe earthquake. However, the city was close to the epicenter and hit by the strongest tremors, causing casualties in the thousands and over \$150 billion in damage. Even though the Japanese government increased its spending on earthquake-resistant building structures and disaster prevention planning has improved, many questions remain.

Assistant Professor <u>Wassim Ghannoum</u> is working with Japanese investigators at the National Research Institute for Earth Science and Disaster (NIED) E-Defense shake table facility to advance research on preventing structural system failures. The E-Defense (Earth-Defense) is the world's largest earthquake shaking table and can support real-life building specimens weighing up to 2.5 million pounds.

In 2010, two full-scale, four-story reinforced concrete (RC) buildings were tested under increasing multidirectional seismic excitations to near collapse. The ground motions used were recorded during the devastating 1995 Kobe earthquake. This test series is the only one to date in which full-scale, multi-story RC buildings were subjected to all components of recorded ground motions to near collapse damage states. Ghannoum, other U.S. researchers, and Japanese investigators collaborated on the design and instrumentation of the building specimens which took place at the facility.

The test program intends to shed light on the full system-performance of modern buildings built in accordance with today's seismic design codes and find ways to improve the safety and damage-resilience of such structures when subjected to extreme earthquakes.

The results showed severe damage of shear walls and beam-column joints and loss of integrity. Even though these structural systems were designed according to current earthquake engineering practice, the team's observations raised serious questions about current seismic design codes and construction practices.



Severe damage observed in first-floor joints indicates that improved design code requirements are needed.

Since the shaking table tests produced a wealth of data from which lessons can be learned, Ghannoum is now tasked with performing in-depth analyses. His current National Science Foundation (NSF) funded project "Behavioral and Analytical Investigations of E-Defense Shaking Table of a RC Structure" aims to uncover the causes of this performance and provide recommendations for improvements in analysis and design practices.

"The project focus is on understanding the behavior of modern reinforced concrete buildings during extreme earthquakes and advancing simulation capabilities that are critical to the design process. We now have a good handle on the behavior of the tested structures and are currently evaluating the accuracy of advanced analytical models. The end goal is to propose our own analysis tools that best simulate the seismic behavior of reinforced concrete buildings," says Ghannoum.

As the project's PI, Ghannoum's objectives are to assess the validity of current behavioral knowledge and design codes in light of the experimental program, assess the accuracy of the current analytical methods for this common type of structure, and to recommend improvements on behavioral and analytical fronts.

In addition to strengthening ties with E-Defense researchers, he will also incorporate new knowledge into his graduate course which covers the behavior or reinforced concrete structures. Civil engineering graduate student and teaching assistant Jinhan Kwon is also working with the team.

Ghannoum is the chair of the American Concrete Institute's committee on Seismic Repair and Rehabilitation, and was on EERI's committee coordinating technical assistance to Haiti.

Certification and Professional Development Units (PDUs)

Your Certification Committee came together to write this article outlining the four (4) Professional Development Unit (PDU) Categories. We had the intent to point out just how easy it is to acquire 30 PDU credits each year.

Professional Development Units (PDUs) are simply a validation that we, as Certified Professional Estimators, are actively fulfilling our responsibilities to our fellow CPEs and to the cost estimating profession. This is a benefit to each of us, our Society, and those we serve.

ASPE may require more PDUs than other comparable organizations; however, we also offer more opportunities to obtain PDU credits. Remember, to fulfill the CPE Renewal requirements, PDUs must be earned in more than one Category. The following outline describes each Category.

CATEGORY I: CONTINUING EDUCATION/TRAINING

If you have attended a workshop, seminar, educational class, or informative meeting that is relevant to Estimating, you will meet the requirements of Category I. The majority of activities in this Category earn you 0.5 to 1.0 PDU credit per hour of attendance. **Examples**

- Webinar/DVD/Webcast: If you are learning and attend for 2 hours, I PDU credit is earned
- Lunch & Learn: If you are learning and attend for 2 hours, 1-2 PDU credits are earned
- Academic Courses/College or Trade School (online or in person): 2 hours of coursework earn you 2 PDU credits

CATEGORY 2: AUTHORSHIP, PRESENTATION, TEACHING

If you wrote an article for a periodical, paper or book; if you delivered a presentation; or if you served as an instructor for an industry-related course, you will earn at least 1 PDU per hour. Remember, in this category, you are also able to claim equal credit for your prep time.

- Reviewing Technical Paper(s) for Candidates in the Certification Program will earn you 4 PDU credits
- If you create a blog and submit it to the SBO and it is published, you will earn 0.25 PDU credits for each published blog.
- Instructing or teaching a class or presentation on estimating.

CATEGORY 3: PROFESSIONAL ORGANIZATIONAL ACTIVITIES

Do you have an industry related certificate or license, perform in a leadership role in your Chapter or Region, or serve on an industry related professional committee? This Category also includes ASPE Chapter Meetings, attendance at Regional Meetings, and participation in Summit activities.

- Attendance and participation in Chapter/Regional or ASPE sponsored meeting, workshops, etc. will earn you 1-3 PDUs
 depending on the time and level of participation or educational opportunity.
- Professional Membership with other industry related organizations (examples, AACE International, CSI) will earn you 1 PDU per active membership.
- Elected leadership role for Chapter or other ASPE organizations can be 3-5 PDUs annually.

CATEGORY 4: OTHER PROFESSIONAL ACTIVITIES

If you are more community minded and share your estimating knowledge and skills in your community, you will be awarded PDUs for court mediation, awards of professional excellence, and volunteering.

- Community volunteer work (relevant to estimating) provides you I PDU per hour.
- Media interview, source of press release (live or in print, relevant to estimating) earns you I PDU per instance, published article.
- Volunteer job training activities related to the estimating profession earn you 1 PDU per hour.
- If you support a CPE Candidate and act as a proctor for their GEK or DST Exam, you will earn 2 PDU credits per exam that you proctor.

2018 CERTIFICATION PROGRAM CHANGES Effective 07/01/2018

The ASPE Board of Directors, together with the Certification Committee, has unanimously approved the following updates/changes to the ASPE Certification Program.

- CPE Candidate: Fails 2 Attempts / Carry-Forward Passing Grade(s) to Reapplication
 - Approved: Candidate will be allowed to carry-forward Passing Grade(s) and re-take failed/or incomplete portion of the Certification Program ONLY if ...
 - Candidate reapplies in 6-12 Months from the month that the fail occurred AND
 - Candidate must complete the failed/or incomplete portion within three (3) months from the re-application acceptance date
 - Note: DST Part 1 and DST Part 2 are separate tests but are weighted as 1 item. If Candidate fails either Part of the DST Exam, both Part 1 and Part 2 must both be retaken
 - ▲ Note: Candidate must earn a score of 70% on DST Part I and DST Part 2 of the DST Exams
 - ▲ Incentive for Applicant to reapply and continue in the Certification Program toward CPE designation

• CPE Candidates: Fails – 2 Attempts / Requires 6-Months Waiting Period prior to Reapplication

- Approved: Offer \$100 Credit to Application Fee if Candidate reapplies in 6-12 Months
- ▲ Incentive for Applicant to reapply and continue in the Certification Program toward CPE designation

• PDU Requirements

- Approved: Reduce from 30 PDUs to 24 PDUs Annually
- PDUs do not carry over into subsequent years
- ▲ Effective Date: Cycle Start Date 01/01/2019

CPE Renewal Period

- Approved: Annual Renewal vs every 3-years
- **No Change in Fees/Renewal Fees:** \$50 Annually
- **Effective Date:** Scaled/Beginning with 2018 Cycle Renewals
 - 2018 Renewals/Extend 5 Months from 07/31/2018 Cycle End to a 12/31/2018 Cycle End
 - 2019 Renewals/Extend 5 Months from 07/31/2019 Cycle End to a 12/31/2019 Cycle End
 - 2020 Renewals/Extend 5 Months from 07/31/2020 Cycle End to a 12/31/2020 Cycle End

• CPE Renewal Date

- Approved: Adjust to Annual Cycle End Date of 12/31
- Coincide with Membership Renewal
- **Effective Date:** Scaled/Beginning with 2018 Cycle Renewals
 - 2018 Renewals / Extend 5 Months from 07/31/2018 Cycle End to a 12/31/2018 Cycle End
 - 2019 Renewals / Extend 5 Months from 07/31/2019 Cycle End to a 12/31/2019 Cycle End
 - 2020 Renewals / Extend 5 Months from 07/3 I /2020 Cycle End to a 12/31/2020 Cycle End

• CPE On-Time Renewal: Cycle End Date vs Expiration Date

- Approved: Dates to be the Same
 - No longer 12-Month Grace Period to submit PDUs

Only a 30-Day Grace Period for Renewal (for submission of PDUs)

- After 30-Day Grace Period Expires = Late Renewal or Reactivation will be required
- **Effective Date:** Scaled/Beginning with 2018 Cycle Renewals
 - 2018 Renewals/Extend 5 Months from 07/31/2018 Cycle End to a 12/31/2018 Cycle End
 - 2019 Renewals/Extend 5 Months from 07/31/2019 Cycle End to a 12/31/2019 Cycle End
 - 2020 Renewals/Extend 5 Months from 07/31/2020 Cycle End to a 12/31/2020 Cycle End
- CPE: Late Renewal Fees
 - Approved: \$50/Calendar Month Penalty until required PDUs are submitted
 - **Effective Date:** Cycle Start Date 01/01/2019

• CPE Reactivation

- Approved: \$1,500 Reactivation Fee
- Approved: This is a one-time only option available to a CPE
- Must occur within 2-Years after Cycle End Date
- No PDUs required during Reactivation
- After Reactivation, PDU requirements will continue in order to maintain CPE Certification
- Effective Date: Cycle Start Date 01/01/2019

• CPE Lifetime Status

- ▲ **Approved:** With CPE Renewal accomplished Annually, Lifetime Status will require 14 consecutive On-Time Renewals (= 15 Years as CPE in good standing with Membership in Good Standing)
- ▲ Time starts over at 0 Years as CPE, if/when a CPE has been Revoked or granted Amnesty
- **Implementation:** Application review required by Certification Team
