# San Diego International Airports Developing Sustainably, Responsively, and Economically

Serving 22,525,801 passengers in 2017 (up 8.54% from the previous year) with a single asphalt and concrete runway of 9,401 feet x 200 feet, the San Diego International Airport was named the busiest single runway in the world, behind Mumbai and London Gatwick. It serves 18 passenger airlines and 5 cargo airlines that fly direct to 65 destinations. This international hub covers 663 acres of waterfront property and is owned

and operated by the San Diego County Regional Airport Authority. In 2017 the airport provided nearly 116,571 jobs with an annual payroll of \$3.9 billion. If off-airport parking and air cargo facilities are included in the numbers, the total number of jobs adds up to 1,400 with \$57.5 million in total payroll and \$180.7 million in annual output. Six million visitors in 2017 spent \$9.1 billion in economic output. Employment has increased by 31% while passengers have increased from 17.3 million in 2012 to 22.2 million in 2017. With an additional 4.9 million people, an upgrade in facilities, transportation, navigation and external and internal structures are sorely needed.

#### The Green Build Predecessor to the Airport Development Plan (ADP)

The airport was renamed from the San Diego Municipal Airport - Lindbergh Field to The San Diego International Airport by its new owners, the San Diego County Regional Airport Authority, in 2002 as a "better fit for a major commercial airport." The expansion and enhancement program "The Green Build" demonstrated the Airport Authority's dedication to sustainability efforts which have continued to be at the forefront of its development. The Green Build created 1,000 jobs in addition to 10 gates in Terminal 2, the nation's largest USO Center, a two-level roadway separating incoming and departing passengers, more security lanes to improve terminal traffic, and expanded 9,200 ft for concessions for a total of \$907 million over 4 years. Sustainability features include low-flow fixtures, a reflective room that absorbs less heat and keeps the terminal cool, solar panels that produce 2kW of energy and a partnership with Borrego Solar Systems to equip the terminal with a 3.3MW solar system over its roof.

#### Features of the ADP

The Airport Authority recognizes that its next master plan, the Airport Development Plan, will need to meet a variety of needs for an unprecedented number of people as passenger traffic is expected to increase from 27 to 33 million by 2030.

To meet demand through 2035, the San Diego International Airport will redesign Terminal 1, in addition to revisioning the transportation to and from the airport. The call for an Intermodal Transit Center (ITC) would provide a connection point for the trolley, Amtrak, and Coaster passengers to the airport. Separating arriving and departing passengers is part of the ADP, along with the following elements. Phase 1 of the ADP would include:

- 1. Terminal and Roadways: construction of a new 30-gate terminal building including: new entry, circulation, arrival and departure roadways, pedestrian bridges, demolition of buildings, surface features and utilities, new and relocated utilities, storm drainage collection, storage and transmission facilities, and a central utility plant upgrade. The Airport Authority has earmarked \$166 million for a new entry roadway that will connect Laurel Street and Harbor Drive to the airport. Projected completion date is 2026.
- 2. Administration Building for the Airport Authority.
- Airfield Pavement: a terminal apron, taxiways, and overnight aircraft parking with associated lighting, signage and utilities.
- 4. Structured parking: if there is enough demand, a multi-story 7,500-space parking structure to serve Terminal 1 will proceed.
- 5. Additional changes for Terminal 2 include increasing the total number of gates to 61.

Completion of the redevelopment plan is not expected until 2035.

#### Strides in Sustainability

In 2017 SAN signed the "Airports Sustainability Declaration," a voluntary and non-binding call to develop, implement, and expand initiatives that will improve the airport and its surrounding communities. Part of this initiative is to promote 4 key principles: collaboration, transparency, innovation, and engagement. SAN is implementing a portfolio of policies and projects that supports the Airports Sustainability Declaration and its principles.

It is the "model for sustainability efforts for airports across the country" (Sustainability at SAN in 2018). This is seen in the airport's LEED Platinum certification for The Green Build terminal expansion, the first certified commercial airport terminal in the world. SAN has received recognition and awards for its Green Concessions Program and the Good Traveler carbon offset program.

This year it will be working with SDG&E to dedicate 45 new electric GSE chargers at Terminal 2 under Senate BIII 350. SAN will be updating its Air Quality Management Plan and develop a new Clean Transportation Plan to research and identify new opportunities to reduce carbon emissions and improve local air quality. # Recap Article about the December 2018 Joint ASPE/CSI Breakfast Meeting: "2019—A Year of Change"

s Christmas looms on the horizon each year, we look forward to the opportunity of joining with our fellow construction professionals from the San Diego Chapter of the Construction Specifications Institute in welcoming our economic prognosticator, Alan Nevin with Xpera Group, to gaze into the future 12 months and share his vision for the prospects for the real estate and construction sectors as how they could influence market conditions for our industry. On Friday, December 15<sup>th</sup>, 28 members and guests from ASPE and 14 members from CSI gathered at the Admiral Baker Golf Course Clubhouse to hear another insightful presentation by Alan.

His PowerPoint slides described these projections and statistics:

#### **Economic Forecast in the United States**

- ▶ The **population** will continue to increase by more than 2.0 million annually.
- ▶ **Employment** will continue to expand at a pace of 2.0-2.25 million jobs annually.
- ► The **unemployment** rate will remain in the 4.0% range.
- ▶ **Job openings** will top 6.5 million, more than double that of 2010.
- ▶ Oil prices per barrel will remain in the \$60-80 range.
- ▶ **Inflation** will be in the 3-3.5% range, higher than reported by the Feds.

#### 2019 Real Estate Picture in the United States

- ▶ 30-year mortgage rates will remain in the 4.5-5.5% range.
- ► Construction will continue to strengthen, reaching an output of 1.1-1.2 million residential units, as millennials increase family formations.
- ► The non-residential construction market will continue to expand thanks to major increases in infrastructure and military spending.
- ▶ Apartment vacancy rates will be in the 3-4% range and rents will increase 4-5%.

#### **Existing Home Sales in San Diego County**

- ▶ Sales Volume: Down 10-20%; biggest decline in high end product.
- ▶ **Prices:** Dead flat, except for selected zip codes.
- ▶ Investment opportunities. OK but not brilliant.

#### San Diego Apartment Prices

- ► Prices will flatten, but not collapse.
- ► Rents will be stable with increases tough to come by.
- ▶ New higher end projects will be giving rent concessions and not hit their proforma rents.
- ► The volume of transactions will decline 10-20%.
- ▶ The urban core areas will continue to be strong for smaller projects.
- ► Cap rates will move upward, but not by much.

#### Non-Residential Construction in San Diego County for 2019

- ► Substantial uptick in non-residential construction.
- ▶ Led by increases in infrastructure, military, hotel and apartment construction.
- ▶ Renovation will account for 25-35% of non-residential construction spending.

47% of the population growth in the United States occurred in California, Florida and Texas.

Job additions led the way in these three states as well:

Texas 385,700 California 309,000 Florida 232,600

San Diego County will experience a 30,000 increase in population per year up through 2035.

Professional and Business Services continue to represent the #1 major economic driver for San Diego County which includes many jobs in the construction sector. Leisure and Hospitality is a distant second, while the Uniformed Military (Department of Defense) lags poorly in third position.



Responses from Mark Olsen, CPE—Madsen, Kneppers & Associates, Inc.



- 1. When did you get the CPE certification? August 31, 2016
- 2. What made you take CPE certification? A desire for both personal and professional development along with wanting to obtain the best recognition of high achievement within the industry.

- 3. How useful is it for you to have the CPE certification? As a consultant, my estimates are constantly challenged and compared with others for accuracy and precision. While the CPE certification raises my credibility, it's the continuing education and training that allows me to be the most knowledgeable estimator possible.
- 4. What do you suggest to other estimators regarding getting certified? Not only will obtaining your CPE certification sharpen your estimating skills, it also opens doors and provides networking connections with other professionals who also desire to be the best in the industry.
- 5. Brief description of your certification process, estimating life and any other comments?

I was able to review the requirements and start the process online at aspenational.org. I chose a technical paper topic that I am extremely familiar with and enjoy writing about. After joining the local San Diego ASPE Chapter 4, it was easy to get connected with a proctor who was instrumental in providing guidance with the testing process. While the General Estimating Knowledge Exam was straight forward, it took two attempts to complete the Discipline Specific Test, but that actually provided an even greater sense of accomplishment.

Life with the CPE certification has accelerated my growth and development as a professional estimator. Traveling to Regional and National ASPE conferences has expanded my knowledge of how our industry is evolving and where my career can take me. I highly encourage all members to obtain their CPE certification and become more involved with ASPE locally and nationally.

#### 101 INTRODUCTION TO CONSTRUCTION ESTIMATING (online)

Learn the basic principles of construction estimating. Topics to be studied include: organization of the estimate, types of estimates, elements of an estimate, quantity take-off techniques, pricing techniques, adjusting the estimate for a variety of variable factors, estimating labor, materials and equipment, and profit and overhead markups. Students will learn about the different types of estimates and how to organize an estimating document. This course will build a foundation of knowledge that the student will use while estimating virtually any individual trade or project type.

Learn about quality control procedures for various materials, material manufacturing processes, and the physical limitations of the materials being studied. The regulatory environment under which materials are manufactured and incorporated into new structures will be studied.

#### 108 CONSTRUCTION EQUIPMENT AND METHODS (online)
